

## California Thoroughbred Breeders Association

The California Thoroughbred Breeders Association, founded in 1937, is dedicated to the advancement of Thoroughbred breeding and racing in the state and is the legal registering agency for California-bred Thoroughbreds, administering \$30 million annually in purses and bonuses available to breeders and owners of horses bred in the state. This includes more than \$5 million in breeder awards and nearly \$2 million in stallion awards.

The all-time leading Cal-bred money earners are two-time Breeders' Cup Classic winner Tiznow (\$6,427,830), Best Pal (\$5,668,245), Lava Man (\$5,268,706), Snow Chief (\$3,383,210) and Bertrando (\$3,185,610).

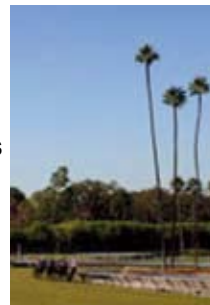

**"Now More Than Ever It Pays To Breed And Race Cal-Breds!"**

■ CTBA administers California's lucrative incentive awards program, which includes Breeders Awards, Owner Awards, Stallion Owner Awards, and the Cal-bred Race Fund. Those awards totaled nearly \$14 million last year.

■ The popular Cal-bred Maiden Bonus Program, which adds \$20,000 to owners of winners of maiden allowance races in Southern California and \$10,000 to the owners of winners of maiden allowance races in Northern California and at all Fair meets.



■ Cal-bred Restricted purses currently total over \$15 million. CTBA participates in three special days of restricted racing with generous purse structures.

## MAIDEN BONUS PROGRAM

I. A \$20,000 bonus made available for owners of registered California-Bred or Sired maidens in Maiden Special races at the Santa Anita, Hollywood Park and Del Mar meetings in Southern California; and a \$10,000 bonus for owners of registered California-Bred or Sired maidens in Maiden Special races in Northern California and at all Fair meetings throughout the state. Beginning in 2011, only races at 4 1/2-furlongs or longer will qualify.

*\*Paid directly to the owner within 45 racing days after the win.*
