The New Rules

Bert Pilcher Jr. and partners reach the big time with Three Rules

FOR 36 YEARS Bert Pilcher Jr. employed a business model that worked to his satisfaction. For a commercial breeder it was quite simple: breed mares, raise their foals, and sell them. Of course, there was the occasional horse that failed to sell, but, by and large, Pilcher stuck to the plan... that is, until he threw caution to the wind.

The horse at the center of Pilcher's change of heart is Three Rules, whom Pilcher co-bred and co-owns with his friends Geoff Roy and Tom Fitzgerald. The Florida-bred son of Gone Astray swept this year's Florida Sire Stakes series for 2-year-olds at Gulfstream Park and entered the Sentient Jet Breeders' Cup Juvenile (gr. I) undefeated in five starts. Although

not the outcome Pilcher and his partners hoped for, Three Rules' sixth-place finish at Santa Anita Park did not diminish their faith in their colt, who will be pointed toward the major 3-year-old stakes in South Florida this winter.

It's a story that almost never was—at least for Pilcher and his partners. Born, raised, and broken on Pilcher's Shade Tree Thoroughbreds farm near Reddick, Fla., Three Rules turned heads early on. The fluidity of his stride as he romped in the paddock as a youngster; his self-assured manner as a yearling; and then, later, the quickness he exhibited in his breezes had Pilcher believing this colt would command a good sum of money at the Ocala Breeders' (continued on page 42)

Sale Co.'s auction of 2-year-olds in April.

"I liked the colt from Day 1," Pilcher said recently. "There was something about him. Everybody says that about their horse: 'Oh, he was different.' But I never really experienced it until this colt came along. There was something about himhe just seemed so confident in everything he did."

Pilcher, 59, went as far as walking into the OBS office to deliver the paperwork on Three Rules, but he just couldn't quite summon the willpower to turn it over to the clerk.

"While I was driving to OBS, I was thinking, 'Man, why am I selling this horse?' " Pilcher, who has also turned down offers on Three Rules after his racing career commenced, recalled. "I loved him, but then I thought, well, that is the reason you should sell, because everyone else will love him, too.

"When I was fixing to hand the paperwork to the girl, something inside me told me not to do it," he continued. "I knew I would get a lot of money for him, but I wouldn't get what he was worth. He was the perfect horse for me."

His partners, who weren't keen to sell either, remarked to him later that it was Pilcher's late father, Hubert, who was the voice in his head, saying, "Don't sell this horse; he's the one you're looking for."

Hubert Pilcher Sr., who built the 57-acre Shade Tree Farm in 1980, died in 2008. As a teenager, the elder Pilcher came to Florida from his native Georgia and found a job at the legendary Ocala Stud farm. He later became the farm manager of the former Meadowbrook Farms, near Ocala. When he opened Shade Tree, working beside him every day was his son, Bert Jr., who took over operations after his father's death.

"My dad was a fabulous horseman," Pilcher said. "Some people have it, some (continued on page 44)

people don't, and he had it. He loved breeding horses and had a really good eye for a good mare and a good-moving racehorse. We made our living with horses with marginal pedigrees because we didn't have the money to purchase really top stock."

The land that Shade Tree—named such for its abundance of live oak trees—was built upon was of particular appeal to Pilcher's father.

"Dad liked it because he thought the lime in the land put calcium in the water and that does something for the bone of the horse," Pilcher explained. "That was one of his theories. I can't knock it because we raise solid horses."

In addition to the original parcel of land, which has three barns, Shade Tree leases 50 nearby acres to accommodate broodmares and their foals. Pilcher also leases a training barn at Starting Point Training Center.

Shade Tree is home to about dozen broodmares owned by Pilcher and his

partners. There are also another dozen or so broodmares that are boarded there. Pilcher said during the breeding season the number of broodmares increases as he has clients who use the farm as a birthing facility.

Pilcher almost didn't follow in his fa-

ther's footsteps. Upon graduating from the University of Florida with an animal science degree, he had his heart set on becoming a veterinarian. But after failing twice to gain admission at the newly opened vet program at UF, which was receiving thousands of applicants for just hundreds of spots, a dean at the school sat Pilcher down and steered him back to his family's farm.

"He told me just go to your farm and you'll be a lot happier because you'll do everything there you would do here, anyway, and just enjoy your farm," Pilcher recalled. "And you know what, at the time, I hated him for it.

"But that dean was right," he added. "If I had been a veterinarian, I wouldn't have handled it as well because I get too involved with each animal, and if I was a veterinarian and saw everyone's problems, it probably would have put me over the edge. It turned out to be the right career move for me."

Pilcher lives at Shade Tree with his wife of 36 years, Martha, whom he met in college. The couple have two adult children, twins Albert III and Louise. Neither of their children is involved with the farm, but Pilcher said his wife is a valued member of the operation.

"When I built the farm—and people won't believe this—the first three years I never left the 57 acres but twice," he said. "Martha, bless her heart, she stuck with me. She loves the horses too. She's been an unbelievable partner in this deal because she does all the bookwork for me and keeps me straight and organized, which is really a hard thing for anybody to do."

As hard as Pilcher works, he emphasizes he is not a one-man show, and credits the dedication of farm manager Alejandro Sanchez and farm trainer Gene Corbin, and Three Rules' trainer, Jose Pinchin, with the success of Shade Tree Thoroughbreds.

Three Rules won his first five starts

this year, all at Gulfstream Park. After breaking his maiden over a sloppy track in June, he won the Birdonthewire Stakes by five lengths in his second start, then ran through the Florida Stallion Series, taking the Dr. Fager Stakes by seven lengths, the Affirmed Stakes by 5½, and the In Reality Stakes by 10. He has earned north of \$700,000 to date.

Although Pilcher has bred and sold other stakes winners, Three Rules is the first stakes winner he has owned. Besides the fact his instincts of not selling the colt proved to be spot-on, Pilcher is also proud Three Rules is a product of four generations of progeny linked to Shade Tree.

The great-granddam of Three Rules, Dark Imp, was one of the first broodmares who came to board at Shade Tree after it opened. She was owned by the late Joy Carpenter, a client of Pilcher and his father. Bert Pilcher Jr. foaled Dark Imp's first foal, Joy's Delight, the dam

of Joy Rules, Three Rules' mother.

"After Joy's Delight ran for Mrs. Carpenter, I purchased the mare with my partner Geoff Roy, who made a deal with Mrs. Carpenter because we always liked the mare. She was always really fast, although tough to handle," Pilcher explained. "I think a lot of her racing career was compromised by her disposition. Each generation has gotten better in disposition. It seems as we get farther away from Dark Imp, we keep the ability, but now we get the intelligence that Three Rules has."

Pilcher bred Joy Rules back to Gone Astray this year, so a full sibling to Three Rules awaits. In the meantime Pilcher and his partners are bullish on a half sister to Three Rules.

"I've got a yearling filly by Soldat out of the mare and, boy, is she training good," Pilcher enthused. "I've got her galloping in the paddock right now. The way she moves, she is looking like she could be something special, too. The chances of having another Three Rules are going to be real slim. But she looks like a nice filly, and if this was a regular year and I was breaking horses, she still would be my pick to go to the races and do well."

Pilcher finds himself in the same position as he was earlier this year with

Three Rules—to sell or not to sell.

"I'm trying to decide on that now because I know she will be fast at the 2-year-old sale and Soldat has a really nice (pedigree) page," Pilcher said. "The thing that has got me a little bit thinking about keeping her is she looks just like her mama and her mama is only 12, but by the time this filly will be running, mom will be 15, and we might need a replacement for her."

And, given the year Three Rules has had, this commercial breeder has every right to deviate from his business model, particularly since the colt gave him the greatest thrill of his professional career.

"Three Rules has been a godsend," Pilcher remarked. "The trip to the Breeders' Cup with him is something I will never forget. It was really an amazing experience, especially for someone like me whose whole life has been racehorses. When you get to go to the Breeders' Cup and see these horses who you think are the best that ever was, and see them training in the morning and racing, and meet their trainers, owners, and riders, and be one of the guys, it's unbelievable. I had an experience that I will never forget."
