
### Dennis Drazin fights for horseracing in New Jersey

BY STEVE HASKIN

ith the loss of two major racetracks over the years and continuous battles with the Atlantic City casinos and state legislature to get slots, New Jersey racing is struggling to remain competitive with surrounding states, most notably New York, Delaware, and Pennsylvania.

If the Garden State is to succeed in achieving its objectives, it very well could be due to the efforts of New Jersey Thoroughbred Horsemen's Association president and legal counsel Dennis Drazin, who has been a ubiquitous presence on the New Jersey political scene for the past several years.

Drazin, who is president of the Red Bank-based law firm Drazin and Warshaw, became a major voice in the state after being named to Gov. Jon S. Corzine's Governor's Commission on the Horse Racing Industry. The Commission was created to "identify, assess, and recommend possible funding solutions for horse racing meets after 2010

and propose long-term funding solutions that will promote the future sustained viability of the horse racing industry in New Jersey."

One of Corzine's final acts as governor in early January was to submit Drazin's name for the position of chairman of the New Jersey Racing Commission. Final approval would come from incoming governor Chris Christie.

Drazin, 58, is not your typical political figure who looks at Thoroughbred racing solely from a business standpoint. He has been involved deeply in the sport since he was a youngster and has been an owner and breeder as well as a lifelong fan.

Drazin, who grew up in Rumson in

Monmouth County, was first exposed to racing through his father, Louis M. Drazin, himself a longtime Thoroughbred owner.

"My father was involved in racing Thoroughbreds in the late '50s," Drazin said. "He took me out to the track as a young kid in 1958, and I got hooked. I used to go to the track with him quite a bit and to the

farm to see the horses. He also spent a lot of time in Florida in the winter, so I'd go to Hialeah and Gulfstream. I became an avid fan of the sport, and one of my best friends growing up was John Kimmel, whose father, Caesar, owned horses in New York. With both our fathers in the racing business as owners, John and I talked about investing in a share of a horse after we got out of graduate school.

"Here we were hanging around the backstretch together, in Jimmy Croll's barn and other places, learning everything we could about horse racing. There was an opportunity to invest in a horse that Jimmy trained who was about to become a stallion, and John and I were going to split a share,

which cost \$50,000. We were going to use our savings to do this and both our fathers were ready to wring our necks. They told us we didn't know what we were doing and to stay out of the business. So, because of our fathers' advice we decided to listen to them and be more conservative, and we backed out and didn't buy the share in the stallion. That horse turned out to be Mr. Prospector."

With their respective fathers batting zero in the advice department, Drazin and Kimmel decided to form a partnership and try again. In 1984, they bought their first horse at public auction, a mare named Key to Paree. They wound up purchasing two mares, and just like that they were in the breeding business.

They bred Key to Paree to Distinctive Pro and got a filly that they tried to sell at

public auction, but were forced to buy back. At the time, Caesar Kimmel was known for the tonguetwisting, risqué names he gave his horses, such as Cunning Stunt and Cold as a Witch's, and Drazin and John Kimmel decided to follow suit by naming their filly Bodacious Tatas.

With Kimmel training, Bodacious Tatas, whose name made her a cult figure, went on to win the grade II Molly Pitcher Handicap and two other stakes, while placing in eight stakes on the New York and New Jersey circuits.

"It took us a number of attempts to get the name approved, but after that, they started to red flag us," Drazin said. "John and I had success racing her, and we've been racing horses together since.

We had our partnership horses from the ones we bred and raced together, and we also raced horses individually. John then took off for New York and I wanted to focus here in New Jersey, because it was close to home and I could get over to see the horses more often that way. We did a lot of pinhooking over the years and raced under the name Aspen Stables.

"John had graduated veterinary school, and he and I pretty much raced and bred everything together. Then in the '90s I branched off on my own and got involved on a larger scale. At one point I got up to about 150 horses, both breeding and racing. I leased farms in Kentucky, New York, New Jersey, and Florida, and had as many as 30 broodmares, but right now I'm down to about 50 horses total. I keep 12 to 15 horses in training, some with Kimmel in

New York, and after Jimmy Croll died I went with Jason Servis and John Forbes in New Jersey."

Drazin's top horses included Gooni Goo Hoo, third in the Barbara Fritchie Handicap (gr. II), whose first three career victories were by 15, 13, and five lengths. After retiring, she was sold at the Keeneland November mixed sale for \$700,000. Another was Better as a Memory, second in the Betsy Ross Handicap (gr. III) and Grecian Flight Stakes; and Bam Bam Bull, winner of the Half Moon Stakes at Meadowlands. Drazin also owned an interest in Century City, who finished third in the 2003 Net-Jets Breeders' Cup Mile (gr. IT), and bred Alyrob, who was second (but disqualified) in the 1996 Santa Anita Derby (gr. I) before finishing eighth in the Kentucky Derby.

"I also bought a share in Seattle Slew when he went to stud, and a lot of the horses I had were by him," Drazin said. "I raced some but sold most of them."

After graduating law school in 1976, Drazin joined his father's law firm, which still bears the name Drazin and Warshaw from that time. They currently have 12 lawyers and about 65 employees in four locations.

"We do mostly litigation—medical malpractice, personal injury, products liability, worker's compensation," Drazin said. "We do the whole gamut. But we also have a large general practice."

In 1975 Drazin began lobbying for the Trial Lawyers Associations. "We were very active in trying to have laws passed that influenced legislation that would favor consumer rights," he said. "I was a trustee and ultimately chairman of their political action committee. I felt in the late '90s that the horsemen just didn't understand the proper way to do things in that regard, and I became involved and very active in trying to assist them. One of the things I did was get involved in applying to the racing commission to use the interest earned on horsemen's funds in order to advance our lobbying efforts and make

political contributions to give us an opportunity to educate legislators.

"Having learned how to do this with trial lawyers, I tried to take those skills and bring them to the horse industry. The racing commission resisted us at first, but ultimately through litigation I challenged their refusal and the courts said that it was a legitimate use of funds and awarded us funds in order to advance the aims of the industry."

In 2004 Drazin was named president of the New Jersey Thoroughbred Horsemen's Association.

"I was then appointed by Gov. Corzine to the blue ribbon panel to try and preserve the horse racing industry in New Jersey and establish increased revenues. I had been active politically, and the governor asked me to serve in that capacity. Every governor we've worked with as far back as I can remember has been very supportive of racing. Corzine did everything he could, with the exception of putting slot machines at racetracks, to assist us. But through these gubernatorial terms we were given \$176 million over the past seven years for purse enhancements. The first money was \$86 million and then \$90

million more over the last three years.

"In 2001 we had advanced legislation that would sign into law the establishment of 15 off-track wagering facilities and account wagering. The projections at the time showed that if they built them all it would have generated probably \$50 million in purses per year between the money for the horsemen and the money for the racetracks. But unfortunately the New Jersey Sports Authority didn't get it together to build all of the facilities yet. They've only built three and they've got a fourth one approved, which they've started working on."

Drazin cited several reasons why the facilities never moved forward as everyone had hoped

"First there was the decision to sell the tracks," he said. "Magna was one of the leading suitors for the racetracks and they wanted to develop their own sites, and that delayed us. Then we had a new commissioner that came into the Sports Authority, and they started to rethink it after they built the Woodbridge facility. They realized how successful it was and wanted to build more, but because of some issues with the legislation with giving towns the right to turn them away, they've been pretty slow in trying to develop the system. They also have a problem in that they're partners in the off-track wagering and account wagering with the Pennwood group, so a lot of our money moved across the river to Philadelphia. And the last thing Pennwood wants to do is build facilities in places that would take business away from Pennsylvania, so a lot of our revenues remain in Pennsylvania. For example, they're not going to want to build in Cherry Hill and compete with themselves. So, at the present, all we have are the facilities in Woodbridge, Tom's River, and Vineland, and the one approved to be built in Bayonne.

'They're generating good revenues. The account wagering system is active, but right now in my opinion it's suffering from some national industry problems with different people not wanting to send their signal in, so we're currently not getting Churchill, Gulfstream, Santa Anita, and Fair Grounds. They're all wrestling with a pricing war. The Midlantic Cooperative, which controls the pricing of these signals and purchasing for New Jersey and some of the surrounding states in the Midlantic region, is trying to negotiate a price to solve the problem. If they don't, there probably will be litigation instituted. Frankly, I'm tired of it, and it is my intention, if the Sports Authority doesn't join with us, to band together and file a suit challenging the fact that they're not sending us a signal. But that would take years to resolve.'

As for the slots, Drazin said that studies and evaluations conservatively show that slots at Meadowlands probably would generate a billion dollars a year in revenue, and a small portion of that would solve the problem for the racing industry.

"The current Governor-elect, Christie, would have the majority of that money to use for whatever other needs for the state—whether education, property tax relief, or some other area he thinks it should go to," Drazin said. "So, slots ultimately may happen for New Jersey, be-

cause they have budgetary problems and it's a good way of raising funds. In past discussions the scheme has been to let Atlantic City have a piece of it and run them. A total of 25% would go to the horse industry, 25% to the operator, 25% to the state, and 25% to the casinos.

"There's no real justification not to do it, because even the casinos themselves are investing in other states. They're in Pennsylvania and New York, and people from North Jersey are not going to go to Atlantic City if they can go across the river to New York or Pennsylvania. I think inevitably the casinos are going to recognize that the only solution for them and us is to do something at Meadowlands. Openly, everybody is working hard toward that end, and the Blue Ribbon panel will come out with its decision in July 2010."

Drazin and the horsemen's association have been very aggressive over the years in terms of minimum live racing protection. They have a guarantee through 2016 as result of extensive litigation and legislation settled with the state that there must be 141 days of live racing. After 2016 the legislation says it can never be less

than 120 days.

Another project Drazin has been pursuing has been a year-round training facility, but with the current economy it has been difficult getting anyone to put money into it.

"We've discussed winterizing Monmouth Park, as well as trying to obtain some land at Fort Monmouth, because that's being divided up and the surrounding towns are in favor of having a training facility," Drazin said. "There also have been discussions about converting Atlantic City Racetrack into a year-round training facility. That would make more horses available for both the New Jersey and Pennsylvania racetracks because of the equidistant location."

Drazin has had several opportunities to enter the political arena on a full-time basis but is comfortable staying close to his law practice and Thoroughbred racing.

"I've had opportunities to run for the senate several times, but I'm much too busy with what I do," he said. "I want to be where I can serve the industry the most, and I think what I'm doing now has placed me in that position."
